NOTE: The Upper Thames River Conservation Authority (UTRCA) is not responsible for any lost, stolen, or damaged property.

### Reservations

- A 3 night minimum reservation that includes either a Friday and Saturday, or a Saturday and Sunday, is required at all UTRCA Conservation Areas (CAs) for the following holiday weekends:
  - Victoria Day long weekend
  - Canada Day long weekend when July 1st falls on a Friday, Saturday, Sunday, or Monday
  - Civic Holiday long weekend
  - Labour Day long weekend
  - Thanksgiving long weekend
- A 2 night minimum stay is required on all other weekends from the third Friday in June to the Labour Day weekend.
- At WCA, back country campsites require a 2 night minimum during all dates from the third Friday in June to the Labour Day weekend.
- Nightly campsite permit holders must be at least 18 years of age. The permit holder must be the primary campsite occupant. The permit holder is responsible for all occupants and visitors to the site.
- A maximum of 6 people are permitted per campsite, including children and infants.
- Reservations are held until 12:00 pm (noon) of the day after your scheduled arrival date.
- Check in time is after 2:00 pm.
- Check out time is before 11:00 am.
- There are no refunds for a shortened stay or inclement weather.

### Changes and Cancellations

- Once a reservation has been confirmed by either phone or internet, any changes or cancellations must be made by calling 1-866-ONT-CAMP (1-866-668-2267) or by visiting the CA website. Please have your booking number ready when calling.
- The following fee(s) will be charged:
  - \$16 for each reservation
  - \$16 for each change
  - \$32 for a cancellation
- Cancellations for overnight campsites made before 2 pm at least 7 days prior to the scheduled arrival date qualify for a full refund (excluding reservation and cancellation fees).
- Cancellations for overnight campsites after 2 pm, 7 days of the scheduled arrival date forfeit all fees paid.



# UPPER THAMES RIVER

## CONSERVATION AUTHORITY

- Cancellations for group camping made before 2 pm at least 14 days prior to the scheduled arrival date qualify for a 50% refund (excluding reservation and cancellation fees).
- Cancellations for group camping after 2 pm, 14 days of the scheduled arrival date forfeit all fees paid.
- Any requests for refunds prior to or during your visit may be requested online and reviewed at the discretion of the Superintendent/Designate.

### **Vehicles and Equipment**

- One vehicle permit is included with your campsite. Additional vehicles require additional vehicle permits, which may be purchased at the time of campsite registration for \$16 per day per vehicle.
- Group camping includes 6 vehicle permits. Additional vehicles require additional vehicle permits, which may be purchased at the time of campsite registration for \$16 per day per vehicle.
- If bringing any motorized watercraft, there is a \$17 daily fee. No personal watercraft (e.g., Seadoo, Jet Ski, Jet Board) are permitted on the reservoirs at any time.
- At no time may there be less than one or more than 3 pieces of sheltered equipment on an individual campsite unless approved by Superintendent/Designate. Only one piece of sheltered equipment can be a tent trailer, house trailer, or self-propelled camping unit.
- Group camping has a maximum of 6 trailers and 36 people, including children and infants.

### **Visitors**

- All visitors to the campground must purchase a daily vehicle pass and park in designated parking areas.
- Visitors must vacate the property by 11:00 pm nightly.
