As part of that process meetings have been scheduled with implementers for the purpose of providing them with information regarding the packages and requesting them to submit their comments by June 1<sup>st</sup>.

He advised the members that the Source Protection Plan is to be submitted by August 20, 2012. He noted it is unlikely consultation process will be completed by that date, and therefore we will be requesting an extension to the end of November, 2012.
